Martin David appointed Bishop of Ostrava-Opava

The Roman Catholic Diocese of Ostrava-Opava [Latin: Ostravien(sis)-Opavien(sis)] is a suffragan Latin diocese in the Ecclesiastical province of the Archdiocese of Olomouc in Moravia and Silesia, Czech Republic. It is the youngest and the eighth diocese in the territory of the Czech Bishops' Conference, one of two dioceses that were established by the Pope following the democratic revolution in Czechoslovakia in 1989. It was preceded by the Diocese of Pilsen, in the Ecclesiastical province of the Archdiocese of Prague (1993).

The diocese of Ostrava-Opava was established by the Bull of John Paul II *Ad Christifidelium spirituali* of 30th May 1996 and was separated from the existing Archdiocese of Olomouc to include the entire historical land of Silesia in the Czech lands with its capital Opava and a small part of north-eastern Moravia, which includes most of Ostrava, the second largest town in Moravia. The seats of the bishop in this new diocese are the Cathedral of the Divine Saviour in Moravská Ostrava and the Co-Cathedral of the Assumption of the Virgin Mary in Opava.

The first bishop was Mons. František Václav Lobkowicz OPraem (1996–2022). On 4th July 2023, Mons. Martin David (pictured below) became the second bishop.



He was born on 15th August 1970 in Čeladná in the Diocese of Ostrava-Opava. After completing his military service, he studied at the Sts Cyril and Methodius Faculty of Theology at Palacký University in Olomouc. He was ordained a priest on 24th June 2000 and was incardinated into the Diocese of Ostrava-Opava.

Firstly, he was vicar in the Co-Cathedral of the Assumption of the Virgin Mary in Opava (2000–2002) and in the following years was parish administrator and parish priest in two places. From 2008, he was appointed general vicar and in 2017 titular bishop of Thucca in Nu-

midia and auxiliary bishop of the Diocese of Ostrava-Opava. On 1st June 2020, he was appointed Apostolic Administrator *sede plena* of the Diocese of Ostrava-Opava and on 21st February 2022 Apostolic Administrator *sede vacante* of the same diocese. He is chairman of the Liturgical Commission of the Czech Bishops' Conference.

We wish Bishop Martin David God's protection, good health and lots of success in his pastoral care, so that in the eyes of the Most High he may be a shepherd according to His Heart.


