Order of the White Lion Awarded to Cardinal Dominik Duka

Mr. Miloš Zeman, President of the Czech Republic, awarded the highest order of the Czech Republic, the Order of the White Lion of the First Class to Cardinal Dominik Duka OP, Archbishop of Prague and Primate of Bohemia, for "particularly outstanding meritorious services to the Czech Republic" during the festive ceremony in the Vladislav Hall of the Prague Castle, at the occasion of the Independent Czechoslovak State Day on 28th October 2016. As President Zeman declared, all awarded persons are connected by a common motive related to roots of the society. Christianity and Christian values are the deepest and longest tradition which is typical of Europe as well as the Czech nation. According to President Zeman, he continues in tradition of his predecessors, who used to award Czech cardinals. "The Order of the White Lion is great honour not only for me, but for the whole church, as it found its place in free society after many years of totalitarianism," Cardinal Dominik Duka commented the award on Twitter.
