Church Law Review Placed Third in Czech Republic

We are pleased to announce that the Church Law Review was placed **third in the Czech Republic and fourth in the Czech Republic and the Slovak Republic** in the best law journal competition in the period 2016/2017 organized by the Society of German, Czech, Slovak and Austrian Lawyers "Karlsbader Juristentage".

The result was announced at a festive banquet at the Grandhotel Ambassador Národní dům in Karlovy Vary on Friday, 9th June 2017. Thirty five Czech and Slovak journals (ie., several journals more than in the past) entered the competition. We thank the authors of the articles and other contributions published in the Church Law Review, editors and editorial staff, as well as professional reviewers of articles for their excellent performance and help without which such a high-profile evaluation of our specialized journal would not be possible. At the same time, we thank all the loyal readers who have cast their vote for our journal.

77th Church Law Society Evening Event

A festive evening event took place at the baroque refectory of the Dominican priory of St. Giles in the Old Town of Prague on 7th June 2017, during which three new publications from the fields of church law and legal history of churches were presented, namely the *Church Law* by Prof. Jiří Rajmund Tretera and Assoc. Prof. Záboj Horák, *The Beginnings of the Hierarchical Arrangement in the Early Church* by Assoc. Prof. Stanislav Pribyl, and *Mysteries Concerning the Marriage of Anne Katherine Špork* by Prof. Antonín Ignác Hrdina and Hedvika Kuchařová, Ph.D. The authors presented their books, Assoc. Prof. Záboj Horák, Assoc. Prof. Stanislav Přibyl and Hedvika Kuchařová, Ph.D. presented the author readings as well. The evening was accompanied by piano pieces from the works of Joseph Haydn and Johann Sebastian Bach.

Prof. Leszek Adamowicz Received Honorary Doctorate Degree

Prof. dr. Leszek Adamowicz from Lublin (Poland) received the Honorary Doctorate of the University of Prešov (Slovakia) at the ceremonial session of its Scientific Board on 25th April 2017. Prof. Adamowicz is one of the leading Polish experts in canon law. He works at the School of Law, Canon Law and the Administration of the Catholic University of John Paul II in Lublin, is the author of the Polish translation of the Code of Canons of the Eastern Churches, and participated in publication of the Slovak translation of this Code.

Since 1996 he has been teaching canon law in Spišské Podhradie, Velehrad and Brno, together with his colleagues from the Lublin school, as part of the help provided by the school with the education of canon law licentiate students from Bohemia, Moravia and Slovakia. Laudatio was delivered by Assoc. Prof. JCDr. František Čitbaj, PhD., from the Department of Systematic Theology of the School of Greek Catholic Theology of the University of Prešov, a member of our Church Law Society.

High School Principal's Employment Discrimination Claims Barred by Ministerial Exception, p. 3:

A federal court in Indiana has joined others in holding that a principal at a Catholic school is a "minister" for purposes of the ministerial exception. Following her termination as principal at a Catholic high school, M. B. G. sued the diocese for employment discrimination based on sex, age, and disability. Her job description included "[c]oordinat[ing] ... faith community affairs, the theology program, and the integration of faith within the learning process with the chaplain, the campus minister, and the chair of the theology department." Her employment agreement acknowledged and captured in a detailed way the ministerial character of her position. When asked at her deposition whether a principal is considered a ministerial position, she answered: "Absolutely."
