### 23<sup>rd</sup> International Conference Church and State Brno, September 2017

On 14<sup>th</sup> September 2017 an international conference on religion law, held every year by the Department of Constitutional Law and Political Science of the School of Law of Masaryk University in Brno in cooperation with the Church Law Society, took place at the Masaryk University in Brno.

The topic of this year's conference – **Religion and Healthcare** – is related to publication of a document issued by the Czech Ministry of Health on 13<sup>th</sup> April 2017, titled *Guideline on Spiritual Care in Bedside Medical Facilities of Medical Service Providers*, and regulating activity of healthcare chaplains of religious communities. These chaplains have been providing their service for several years in some Czech hospitals on the basis of agreements between the Czech Bishops' Conference and the Ecumenical Council of Churches in the Czech Republic from 2006 and 2011.
