### General Meeting of Church Law Society

On the evening of 15<sup>th</sup> May 2018, a regular session of the General Meeting of the Church Law Society took place in the representation hall of the School of Law of Charles University.

According to a report by Prof. Jiří Rajmund Tretera OP, the Society currently has 497 members (mostly in the Czech Republic, about 50 from Slovakia and another 50 from different countries of Europe and America).

Since the last session two years ago, the Society has done the following:

- published 8 issues of the Church Law Review, printed and [online](#), each issue ranging from 120 to 150 pages, in Czech or Slovak, with some parts translated into English, summaries of articles and biographies of authors in English, German and Italian,
- published 48 issues of [online newsletter in Czech](#),
- published 24 issues of [online newsletter in English](#), which differs in text and photos from the Czech newsletter,
- organized 5 public lectures and discussions under the series *Influence of Law in Society and in Church* in Prague,
- organized 2 international conferences *Church and State* at the School of Law of Masaryk University in Brno,
- organized 7 discussions on biblical topics for students and teachers of law in many churches in Prague,
- organized 2 exhibitions of Czech as well as foreign church law and religion law publications at the School of Law of Charles University in Prague,
- participated in activities of the Czech Christian Academy and the Council of Scientific Societies of the Academy of Sciences of the Czech Republic in Prague.

In the second part of the General Meeting, the usual election of the representatives was made for the next two years, i.e. seven members of the administrative committee and three members of the audit committee. Prof. Jiří Rajmund Tretera OP was re-elected Chairman of the Society, Assoc. Prof. Záboj Horák was re-elected Vice-Chairman.

At the end of the General Meeting, three priests present gave a blessing to the whole Church Law Society in its next activity. The entire meeting of the General Meeting was inspired by the spirit of friendly atmosphere and was a balm for the soul in today's turbulent times.
