

## **Church Law Society Website**

At the beginning of July, the <u>Church Law Review/Basic Information</u> section was added to the Czech and English versions of Church Law Society website. In particular, information on the participation of the Church Law Review in international citation databases **Web of Science** and **Index to Foreign Legal Periodicals** was added.

June 2019 site access statistics reports *access of 310 users* (increase 15.68% over the previous month) and *433 views* (increase 4.34% over the previous month).

## Czech Agreement on Spiritual Care in Health Service Signed

We are pleased to announce that the Agreement on Spiritual Care in Health Service was officially signed in Prague on 11<sup>th</sup> July 2019. Cardinal Dominik Duka signed the agreement on behalf of the Czech Bishops' Conference, as he is the chairman, on behalf of the Ecumenical Council of Churches it was signed by its chairman Daniel Ženatý and secretary-general Petr Jan Vinš. The Minister of Health Adam Vojtěch signed the agreement on behalf of the Czech Republic.

The signing of the agreement is the completion of the many years of effort spent by experts in the field of religion law who have been authorized by administration of churches to deal with representatives of the Ministry of Health. We have informed about this enormous effort in both the Church Law Review and Newsletter. We are pleased that members of the Church Law Society Associate Professor Damián Němec and Dr Petr Jan Vinš have great merit in preparing the agreement.

The signing of the agreement may also be a small feast for religion law teachers at the faculties of law and theology who have been pointing out its necessity for years.

## **Instruction on Spiritual Care at Police of Czech Republic**

Latest information on positive developments in the field of police spiritual care in the Czech Republic was presented by one of the protagonists of this service, Major of the Police of the Czech Republic Jiří Ignác Laňka, deacon and a member of the Church Law Society, at the international conference Fourth Season of Prague Dialogues on Church and State Relations at the Faculty of Law, Charles University, on 14<sup>th</sup> June 2019.

Now we can inform you that the Czech police president Brigadier General Mgr. Jan Švejdar issued an instruction on the provision of spiritual care under no. 121/2019. Care can be provided by clergy of *all religious communities* registered in the Czech Republic (i. e. not only religious communities with special rights).

On 6<sup>th</sup> July 2019, the Czech Bishops' Conference held a plenary session at the pilgrimage site Velehrad (Moravia) and discussed the police spiritual care too.
