On 28<sup>th</sup> August 2019, the Archbishop of Prague, Cardinal Dominik Duka OP, in his palace at the Prague Castle, awarded medals of merit to three judicial vicars of the Prague Church Court who had been in office since the revolution in 1989.

## Holiday Memories of Crosses, Wayside Shrines and Chapels in Czech Landscape

Traditional places of spiritual contemplation in the Czech landscape include about one thousand five hundred chapels, crosses and wayside shrines, in some places also Stations of the Cross, often recently repaired and renovated or modernized. Some of them are owned by religious communities, others are owned by municipalities. They are usually well maintained, which is one of the Czech peculiarities. Under Czech law, no one is prevented from performing religious acts or organizing collective meditations in front of these religious artefacts.
