#### The 72nd Evening Event of the Church Law Society

On Wednesday 25<sup>th</sup> November 2015 another Evening Event took place in the Barocco Refectory of the St. Giles Dominican Priory in Prague. More than fifty participants attended this traditional event, which is organized by the Church Law Society in Prague. On this occasion the Event featured a presentation of Professor Jiří Rajmund Tretera's new book *Church and Law – Miscellanea*, which was published in autumn 2015 by the Leges publishing house in Prague.

The moderator for the evening was R. D. Associate Professor Stanislav Přibyl, Ph.D., IC.D., a member of the Church Law Society's Working Committee. Speakers at the ceremony were His Eminency Dominik Cardinal Duka OP, the Archbishop of Prague and the Primate of Bohemia; JUDr. Jana Sladká Hyklová, Ph.D., the Editor-in-Chief of the Leges publishing house; and Associate Professor Záboj Horák, Ph.D. Each contributed interesting remarks about the publication and its content.

At the end of the first part of the evening Professor Tretera thanked Záboj Horák and Adam Csukás for their assistance with the preparation of the book, and JUDr. Jana Sladká Hyklová, the Editor-in-Chief, for the publication and her detailed work in editing the publication. Professor Tretera noted that the articles included in the book are excellent documentation of the struggle to re-establish religious orders under the leadership of Father Dominik Duka as the Provincial during totalitarian rule and during the reconstruction of freedom in Czechoslovakia and the Czech Republic.

The Event was accompanied by the musical contribution of Štěpán Korenec, a student at the Law Faculty of Charles University in Prague, who played several pieces of classical music repertoire on the guitar.

The Event concluded with a reception, during which discussions continued over wine and refreshments. A number of members of the Church Law Society from Bohemia and Moravia attended the event, as did representatives of the Archdiocese of Prague, and students and professors from universities, including representatives of the Law Faculty of Charles University in Prague and the Hussite Theological Faculty of Charles University in Prague.

#### Good Friday Included into the List of Public Holidays

We announce with pleasure that as of 21<sup>st</sup> December 2015 the Act No. 359/2015 Sb. of 2<sup>nd</sup> December 2015, changing the Act No. 245/2000 Sb., on Public Holidays, as amended, entered into force. Thereby was Good Friday included into the list of public holidays, which are also rest days. A historical injustice committed by the Communist rule, which crossed out Good Friday from the list of public holidays as of 1<sup>st</sup> January 1952, was finally repaired.

Inclusion of Good Friday into the list of public holidays is a significant expression of return of the Czech Republic back to its cultural traditions and historical roots. Concurrently, it is an expression of realization of religious freedom for the majority of believers. Christian Churches, celebrating Good Friday as the anniversary of the Passion of Jesus Christ, will be able to renew their worships and Good Friday ceremonies in traditional hours during the day and believers will be able to spend the whole day in appropriate collected atmosphere.
